**Principals Report:** Completed classroom observations; attended in-service held at Trinity; still collecting digital copies of policies, handbook etc...; viewed ceiling-mounted projector in computer lab at North Campus for interactive teaching which the board saw a brief demonstration.

**Lunch program update:** only a \$316.00 loss for the month; close to break even; Brenda received a good report back for the government funding program. Great Job Brenda!

**Finance:** Reviewed ageing report; Peg and Rod will get together to determine who needs contacting (those close to 3 months past due) reminding them of policy to bring current or their child(ren) will be remove from the FLS rooster. Kids Club past due accounts must also be contacted. Motion as made to consolidate Kids Club checking account with the general account; second and approved.
